ORDER OF COURT SPECIFYING CONDITIONS OF PROBATION

It is the order of the Court that your term of imprisonment imposed after conviction be suspended and that you be placed on probation.

The Court further orders that you shall be on probation until _____, unless sooner discharged. During your term of probation you shall be under the supervision of a Probation Officer of the Court to whom you shall report directly. The following are the conditions of your probation with which conditions you are ordered to observe and comply.

If at any time during your probation you fail to comply with the following Court conditions, your probation may be revoked.

If you violate a condition of probation during the probationary period, a petition to revoke probation may be filed before the earlier of the following:

- (A) One (1) year after the termination of probation.
- (B) Forty-five (45) days after the State receives notice of the violation.

You are advised that the Court may, at any time during your probation, change or modify the Conditions of Probation. That can be done upon the Court's own motion; upon the request of the Probation Department; or upon you own request. The modifications can decrease or increase the severity of your Conditions of Probation.

CONDITIONS OF PROBATION

1. You will obey all laws of the City, County, State and Federal Government.
2. You shall report to your Probation Officer as directed by that Officer. If you are unable to keep a scheduled Appointment, you shall contact the Officer, in advance, and arrange a different time and/or date.
3. You shall keep the Probation Officer informed of your address, telephone number, and place of residence at all times.
4. You shall keep the Probation Officer informed of your employer's name, address and telephone number at all times.
5. You shall notify the Probation Office immediately of any employment, residence, telephone changes, and/or any contact with law enforcement.
6. No illegal or controlled substances are to be consumed, unless medication is prescribed by a physician.
7. You shall not possess drug paraphernalia or any devices for the ingestion of illegal substances into the human body.
8. You shall not be present at any place where any illegal controlled substances is visibly being used, sold, or possessed by any person.
9. When requested, you shall take a breathalyzer, HIV test, intoxilyzer, alcosensor, urinalysis, or any chemical test for the detection of any illegal substance. A failure, refusal, or tampering with the sample is a violation. You are responsible for the cost of such test.
10. You waive your right against search and seizure, and shall permit a Probation Officer, or any law enforcement Officer acting on a Probation Officer's behalf, to search your person, residence, motor vehicle, or any location where your personal property may be found, to insure compliance with probation.
11. You shall waive extradition to the State of Indiana and voluntarily return to this state and appear before the Court when so ordered by the Court.
12. You shall permit your Probation Officer to visit you at reasonable times, at your residence, school, work and elsewhere.
13. You shall operate a motor vehicle only if you have a valid driver's license.
14. You shall obtain a written travel permit from your Probation Officer before leaving the State of Indiana.
15. You shall support your dependents and comply with any Court order of support.
16. You shall not use, purchase, receive or possess any firearms, ammunition, destructive devices or deadly weapons.
17. You shall pay any court appointed attorney fees associated with this case.

ADDITIONAL CONDITIONS OF PROBATION

- _____ 18. All court costs and fines must be paid to the Clerk of the Court at least thirty (30) days prior to discharge from probation, unless otherwise ordered by the Court.

- _____ 19. You shall complete Home Detention of _____ days/months. Abide by all rules and pay all fees. (574) 372-2412.

- _____ 20. You shall comply with Community Service and perform _____ hours, fee of \$50.00. Contact the office in person or by telephone, (574) 372-2412, within 24 hours of your hearing.


