WHEREAS, THE COUNTY HIGHWAY Engineering Department has performed a traffic study at the aforementioned road intersection in accordance to the State of Indiana Uniform Traffic Control Manual and hereby recommend "Stop" signs be installed.


NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the County of Kosciusko as follows:


Cherry Creek Subdivision


1. Amend Ordinance # 05-11-29-003 line 5 to say. Install "Yield" sign on the southwest corner of Master Lane and Blossom Lane-Master Lane Yields for Blossom Lane.
2. Amend Ordinance # 05-11-29-003 line 6 to say. Install "Yield" sign northeast corner of Blossom Lane and Blossom Lane, on the southwest corner of lot #34 – Westbound traffic on Blossom Lane Yields for northbound and southbound traffic on Blossom Lane

ORDINANCE 05-11-29-003

An Ordinance establishing "Stop" signs at various County Road intersections within Kosciusko County, Indiana; and

WHEREAS, THE BOARD OF COMMISSIONERS of the County of Kosciusko has the power to regulate the use of the public ways and rights-of ways; and

WHEREAS, THE BOARD OF COMMISSIONERS has the authority to establish Stop signs on County Highways; and

WHEREAS, THE COUNTY HIGHWAY Engineering Department has performed a traffic study at the aforementioned road intersection in accordance to the State of Indiana Uniform Traffic Control Manual and hereby recommend "Stop" signs be installed.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the County of Kosciusko as follows:

Cherry Creek Subdivision

1. Install "Stop" sign on the northeast corner of Blossom Lane and Packerton Road – Blossom Lane stops for Packerton Road.
2. Install "Stop" sign on the northeast corner of Masters Lane and Packerton Road – Masters Lane stops for Packerton Road.
3. Install "Stop" sign on the southeast corner of Augusta Lane and Masters Lane – Augusta Lane stops for Masters Lane.
4. Install "Stop" sign on the northwest corner of Augusta Lane and Blossom Lane – Augusta Lane stops for Blossom Lane.
5. Install "Stop" sign on the southwest corner of Masters Lane and Blossom Lane – Masters Lane stops for Blossom Lane.
6. Install "Stop" sign on the northeast corner of Blossom Lane and Blossom Lane, on the southwest corner of Lot #34 – Westbound traffic on Blossom Lane stops for Northbound and Southbound traffic on Blossom Lane.

THIS ORDINANCE shall be in full force and effect on November 29<sup>th</sup>, 2005. Passed and adopted by the Board of Commissioners of the County of Kosciusko this 29th day of November, 2005.
