RESOLUTION AUTHORIZING PURCHASE OF SURPLUS COUNTY HIGHWAY DEPARTMENT PROPERTY FROM WHITE COUNTY

WHEREAS:

- 1. The Board of Commissioners ("Board") of Kosciusko County, Indiana ("County"), is the executive body of County government pursuant to the provisions of I.C. 36-2-2-2 and the legislative body of County government pursuant to the provisions of I.C. 36-1-2-9.
- 2. The White County Commissioners hold title to certain equipment formerly used by the White County Highway Department, to-wit: 2015 Bomag pneumatic roller, Model #BW Nt 1 RH-5, Serial #101538701018 (the "Equipment").
- **3.** The Kosciusko County Highway Department has need for and desires to acquire the Equipment for the sum of Fifty Thousand Dollars (\$50,000.00).
- **4.** I.C. §5-22-22-10 states that:
 - 4.1. (a) a purchasing agency may exchange property with another governmental body upon terms and conditions agreed upon by the governmental bodies as evidenced by adoption of a substantially identical resolution by each entity.
 - 4.2. (b) A transfer under this section may be made for any amount of property or cash as agreed upon by the governmental bodies.
- 5. The White County Commissioners have resolved to sell the Equipment to Kosciusko County for said sum, conditioned upon the Board adopting a resolution accepting the Equipment in its "AS IS" condition without warranties of any kind, express or implied, all pursuant to I.C. §5-22-22-10.

NOW, THEREFORE, THE FOLLOWING IS HEREBY RESOLVED BY THE BOARD:

- 1. The Kosciusko County Highway Department is hereby authorized and directed to purchase the Equipment from White County for the sum of Fifty Thousand Dollars (\$50,000.00), with title for the Equipment transferred from White County to Kosciusko County.
- 2. Said purchase shall be in its "AS IS" condition without warranties of any kind, express or implied, all pursuant to I.C. §5-22-22-10.
