**ORDINANCE TO ALLOW THE RECORDER'S RECORDS PERPETUATION FUND
TO SUPPLEMENT THE RECORDERS 2019 BUDGET**

By the affidavit contemplated by IC 36-2-7-10.2(b), the County Recorder has requested to supplement the expenses of her office by paying the salary and benefits for recorder deputies 10078 and 10079 for the remainder of 2019 (April-December) from the Recorder's Perpetuation Fund.

NOW, THEREFORE IT IS ORDAINED AS FOLLOWS:


