**NOTICE OF LOCAL RULE AMENDMENT AND FINDING GOOD CAUSE TO
DEVIATE FROM ESTABLISHED SCHEDULE**

The Judges of the Kosciusko Circuit and Superior Courts, pursuant to Trial Rule 81(B), give notice of an amendment to the Local Court Rule LR43-AR-Rule 8, Kosciusko County Drug Court Fees, and pursuant to Trial Rule 81(D), find good cause to deviate from the schedule for amending local rules. LR43-AR-RULE 8

KOSCIUSKO COUNTY DRUG COURT FEES

Those persons directed to participate in the Kosciusko County Drug Court may be assessed in accordance with the following SCHEDULE OF FEES pursuant to the authority granted by Indiana Code 33-23-16-23:

1. A Drug Court administration fee of \$100.00 per participant payable to the Kosciusko County ~~Probation Department~~ Community Corrections Department.
2. A Drug Court user fee of \$50.00 per month for every month that an individual participates in Drug Court, beginning with the second month of participation. It is payable to the Kosciusko County ~~Probation Department~~ Community Corrections Department.
3. A Drug Court drug test fee of ~~\$20.00~~ \$15.00 payable to the Kosciusko County ~~Probation Department~~ Community Corrections Department.
4. A Drug Court transfer fee of \$25.00 per participant per transfer, payable to the Kosciusko County ~~Probation Department~~ Community Corrections Department.
