to Certify Referendum to County Election Board**



Passed and adopted this 30th day of July, 2010.



WHITKO COMMUNITY SCHOOLS
BOARD OF SCHOOL TRUSTEES
RESOLUTION

WHEREAS, the Board of School Trustees of the Whitko Community Schools (the "School Corporation") is concerned that based on the projected funding per student that it will not be able to carry out its public education duty unless it imposes a referendum tax levy; and


WHEREAS, Indiana Code 20-46-1-8(a)(1) provides that a school corporation may adopt a resolution to place a referendum on the ballot for the purpose of imposing a referendum tax levy as needed in order to carry out its public education duty; and

WHEREAS, because of the financial situation, the School Corporation desires to hold this referendum on November 2, 2010;

NOW, THEREFORE, BE IT RESOLVED by the Board of School Trustees of the School Corporation that it has determined that a referendum tax levy under Indiana Code 20-46-1-8(a)(1) should be imposed in order to carry out its public education duty (the "General Fund Referendum").


BE IT FURTHER RESOLVED that the question to be submitted to the voters in the General Fund Referendum shall read as follows: "For the next seven calendar years immediately following the holding of the referendum pursuant to Indiana Code 20-46-1-8(a)(1), shall the Whitko Community Schools impose a property tax rate that does not exceed 20 cents (\$0.20) on each one hundred dollars (\$100) of assessed valuation and that is in addition to the school corporation's normal tuition support tax rate?"

BE IT FURTHER RESOLVED that the Secretary of the Board of School Trustees shall certify a copy of this resolution to the Kosciusko and Whitley County Councils pursuant to Indiana Code 20-46-1-8.
