



ORDINANCE 20-07-21-001

An Ordinance establishing “Stop” signs at various County Road intersections within Kosciusko County, Indiana; and

WHEREAS, THE BOARD OF COMMISSIONERS of the County of Kosciusko has the power to regulate the use of the public ways and rights-of ways; and

WHEREAS, THE BOARD OF COMMISSIONERS has the authority to establish Stop signs on County Highways; and

WHEREAS, THE COUNTY HIGHWAY Engineering Department has performed a traffic study at the aforementioned road intersection in accordance to the State of Indiana Uniform Traffic Control Manual and hereby recommend “Stop” signs be installed.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the County of Kosciusko as follows:

Install “Stop” signs at the following housing addition locations:

1. Hawthorn Addition:

- Lilly Court and CR 250E
- Basswood Drive and Lilly Court
- Aspen Drive and Lilly Court
- Sage Drive and Aspen Drive
- Sage Drive and Basswood Drive

2. Maxwelton Hills Addition:

- Rogers Court and CR 560E
- CR 560E and CR 1400N (County Line)

3. Acorn Estates:

- Acorn Drive and Levi Lee Road

4. Greystone Addition:

- Greystone Drive and Chapman Lake Drive
- Greystone Drive and Autumn Trail
- Autumn Trail and Greystone Drive

5. Barrington Hills – Sec II:

- Barrington Place and Barrington Place
- Essex Drive and Barrington Place – Southwest
- Essex Drive and Barrington Place – Northeast


South Shore Green Subdivision:

- Dogleg Drive W. and Dogleg Drive E.
- Tee Trail and Dogleg Drive E.
- Mulligan Court and Dogleg Drive E.
- Birdie Court and Dogleg Drive W.

- Eagle Place and Dogleg Drive W.
- 6. Brandwyne Subdivision:
 - Brandwyne Lane and EMS B40A Lane
- 7. Stanton Lake Estates:
 - Potawatomi Lane and Old Field Drive
- 8. Woodfield Estates Addition:
 - Lynnwood Drive N. and Country Club Road
 - Lynnwood Drive S. and Country Club Road
- 9. Hoffman Lake Estates:
 - Clifton Street and CR 700W – Southwest
 - Memory Lane and Clifton Street – Northwest
 - Memory Lane and Clifton Street – Southeast
- 10. Riverlawn Addition:
 - Riverlawn Drive and CR 350N
- 11. North Shore Estates:
 - Shore Lane and North Shore Drive – Northwest
- 12. Deer Creek Estates:
 - Creekside Trail and Nash Drive – Southwest
- 13. Deeds Creek Manor:
 - Laurien Court and CR 225E


