SHERIFF COMMISSARY FUND EXPENDITURES

WHEREAS, IC 36-8-10-21 provides for the establishment of a Commissary Fund into which funds from commissaries at the Kosciusko County Jail shall be deposited and from which the Sheriff or his designee may expend funds for those items enumerated in IC 36-8-10-21(d), including items which benefit the Kosciusko County Sheriff's Department as are mutually agreed upon between the Kosciusko County Sheriff's Department and the Kosciusko County Council pursuant to IC 36-8-10-21(d)(9); and

WHEREAS, the Kosciusko County Sheriff has requested authority to expend such funds for the purposes set forth on *Exhibit A*, attached hereto and made part hereof, and the Kosciusko County Council desires to authorize expenditure of commissary funds for such purposes.

NOW, THEREFORE, BE IT RESOLVED that the expenditure of Kosciusko County Jail Commissary Funds for the use and purposes set forth in *Exhibit A* attached hereto be and the same are hereby approved.

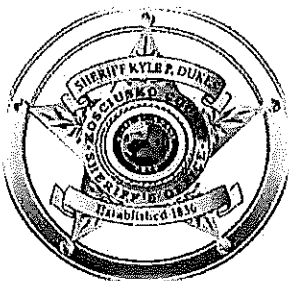

1. Advertising for job applicants and testing
2. Expenses associated with hosting training and agency collaboration events
3. Expenses associated with rental of specialized equipment
4. Expenses associated with rewarding inmates and employees - *excluding wages*
5. Expenses associated with special events for inmates
6. Expenses for advertising community events that promote the Sheriff's Office
7. Expenses for contracting with professional consultants
8. Expenses for installation and service of Sheriff's Office
9. Expenses for remembrances
10. Expenses regarding special details or investigations
11. Haircuts for trustees and indigent inmates
12. Matching funds for grants
13. Postage for indigent inmates
14. Reimbursement for damaged employee property
15. Reimbursement for expenses of inmates in transit
16. Reimbursement for investigation expenses
17. Reimbursement for lost or damaged property
18. Shipping costs regarding department equipment or evidence
19. Supplies or equipment to promote education activities for inmates
20. Any purpose that benefits the Sheriff's Office that does not exceed \$1000.00 - *excluding wages*
